Advice to Dyffryn Clydach Community Councillors & Co-opted Members

The **Councillor's (and Co-opted Members) Code of Conduct** requires you to declare Personal Interests. Some Personal Interests have to be recorded by you in the statutory public register, **within 28 days** of your election or appointment to Office. Such Interests have to be updated by you **within 28 days** of any change.

There is an exemption from having to declare "sensitive information"; the Monitoring Officer can advise you about this.

Interests of Close Family Members

In line with Audit Wales requirements, your declaration must include the interests of Close Family Members i.e. Partners and / or Children. This is in accordance with Financial Reporting Standard 102 (Related Party Disclosure). Further guidance is available at from the Clerk.

In essence a "Related Party Transaction" is a transaction which a Councillor, Co-opted Member, Officer or their close personal associate via another entity (Company, Trust etc.) has with the Council i.e. provision of services or contractual arrangements.

This form enables you to record those interests, or to show that you have no such interests to declare.

Please remember that you still have to declare any relevant interests (including those in this Register) where they relate to matters under consideration at a meeting. Please refer to the Councillor's Code of Conduct for the rules on this.

Complete all Grey areas, Sign and Date form and return to the Clerk.

Personal Interests

You (Councillors and Co-opted Members) must in all matters consider whether you have a Personal Interest and whether the Code of Conduct requires you to disclose that Interest.

You must regard yourself as having a Personal Interest in any business of your Authority if it relates to, or is likely to affect any of the following categories.

i	<i>Details of any employment or business carried on by you;</i> N/A
ii	<i>Details of any person who employs or has appointed you, any firm in which you are a partner or any company for which you are a remunerated director;</i> N/A
